

# MoreVC PRIVACY POLICY

Last Updated: April 19, 2021

In order to ensure transparency and give you more control over your personal data, this privacy policy ("**Privacy Policy**") governs how we, MoreVC ("**we**", "**our**" or "**us**") use, collect and store personal data we collect or receive from or about you ("**you**").

We greatly respect your privacy, which is why we make every effort to provide a platform that live s up to the highest standard of user privacy. Please read this Privacy Policy carefully, so you can fully understand our practices in relation to personal data. "**Personal Data**" or "**Personal Information**" means any information that can be used, alone or together with other data, to uniquely identify any living human being. Please note that this is a master privacy policy and some of its provisions only apply to individuals in certain jurisdictions. Note that you are not obliged, under any legal provision, to provide us with your Personal Information, and you agree to do so at your own discretion. This Privacy Policy can be updated from time to time and, therefore, we ask you to check back periodically for the latest version of this Privacy Policy. If we significantly change the use of your Personal Data from that stated at the time of collection, we will notify you by posting a notice on our website or by other means.

# 1. WHAT INFORMATION WE COLLECT AND HOW WE COLLECT IT

We do not currently require you to provide Personal Data in order to have access to general information available on the website. However, we do receive and/or collect Personal Data from you in the following ways:

- 1.1. When you contact us (e.g. submit a business plan or other request), you will provide us with all or some of the following information: name, email address, phone number, and any messages or other information you wish to share with us.
- 1.2. When you sign up to our newsletter, you will provide us with all or some of the following information: name, email address, phone number, company name and job title.
- 1.3. When you attend a marketing event, provide us with your business cards and/or provide us with your personal data for newsletters or marketing purposes, we collect personal data that you provide us with, such data contains the following types of Personal Data: name, email address, phone number, company name, job title, country, and any other information you may wish to share with us.

In addition, we collect Personal Data of our clients and prospects through publicly available databases and social media profiles, such as name and title of the contact person.

#### 2. HOW WE USE YOUR PERSONAL DATA

If you submit or we collect Personal Data as set forth above, where applicable, we may use your Personal Data for the following purposes:

- 2.1. To analyze trends, administer the website, and to track your movement around the website. We may also use anonymous identifiers in order for us to present you with customized information, and in order to track users.
- 2.2. To answer your questions and to provide support (e.g. to solve problems, bugs or issues).
- 2.3. To send you updates and promotional materials.
- 2.4. To establish a business connection and to send you marketing communications.
- 2.5. To evaluate investment opportunities.
- 2.6. To assist our portfolio companies in reachingout to potential candidates for employment.
- 2.7. To communicate with and perform the applicable agreements with our service providers.

#### 3. HOW WE SHARE YOUR PERSONAL DATA

We generally do not share personal information collected through the website. We may, however, share your personal information (i) with trusted third parties (including our portfolio companies) who work with us and/or provide services to us, (ii) as required by law and when we believe in good faith that disclosure is necessary to protect our rights or those of third parties, protect your safety or the safety of others, investigate fraud, or comply with a court order or other legal process, or (iii) in connection with a corporate change including a



merger, acquisition or sale of assets. In addition, the third parties that support our website analytics tools may be able to view aggregate website usage information that we obtain.

## 4. HOW WE PROTECT YOUR PERSONAL DATA

We have implemented appropriate technical, organizational and security measures designed to protect your Personal Data. However, please note that we cannot guarantee that the information will not be compromised as a result of unauthorized penetration to our servers. As the security of information depends in part on the security of the computer, device or network you use to communicate with us and the security you use to protect your user IDs and passwords, please make sure to take appropriate measures to protect this information.

#### 5. YOUR PRIVACY RIGHTS

You have the right to request access to your Personal Data stored in MoreVC's database. Where you have exercised your right of access, and you have found that your Personal Data is incorrect, incomplete, unclear or not up to date, you have the right to request rectification or deletion of such data. Subject to legal and other permissible considerations, we will make every reasonable effort to honor your request promptly in accordance with applicable law or inform you if we require further information in order to fulfil your request. When processing your request, we may ask you for additional information to confirm or verify your identity and for security purposes, before processing and/or honoring your request. In the event that your request would adversely affect the rights and freedoms of others (for example, would impact the duty of confidentiality we owe to others) or if we are legally entitled to deal with your request in a different way than initially requested, we will address your request to the maximum extent possible, all in accordance with applicable law.

We do not offer our products or services for use by children and, therefore, we do not knowingly collect Personal Data from, and/or about children under the age of eighteen (18). If you are under the age of eighteen (18), do not provide any Personal Data to us without involvement of a parent or a guardian. If you do not agree to this Privacy Policy, please do not access or otherwise use the website and do not share Personal Information with us. We reserve the right, at our discretion, to change this Privacy Policy at any time, and your continued use of the website thereafter means that you accept those changes.
